No.23891—DAFE-AFE-FE-0027/2023/Ag.&FE.— The following Chief District Agriculture Officers (CDAOs) / Joint Directors of Agriculture, Level-II (JDAs-II) are promoted to the rank of Joint Director of Agriculture, Level-I (JDA-I) (Super time Scale) in the Pay Scale of Level-14 of Pay Matrix under ORSP Rules, 2017 on *ad hoc* basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. These *ad hoc* promotions are subject to concurrence of the OPSC on their earlier *ad hoc* promotion to the rank of CDAO/JDA-II. If the OPSC do not agree to concur their earlier *ad hoc* promotion, they will be reverted to the lower grade of the cadre.

Such promotion shall be subject to final outcome of W.P(C) No.166909/2016, 16911/2016, 16622/2016, 16376/2016 & WP(C) No.2076/2024 and other related cases pending in Hon'ble Court, if any.
